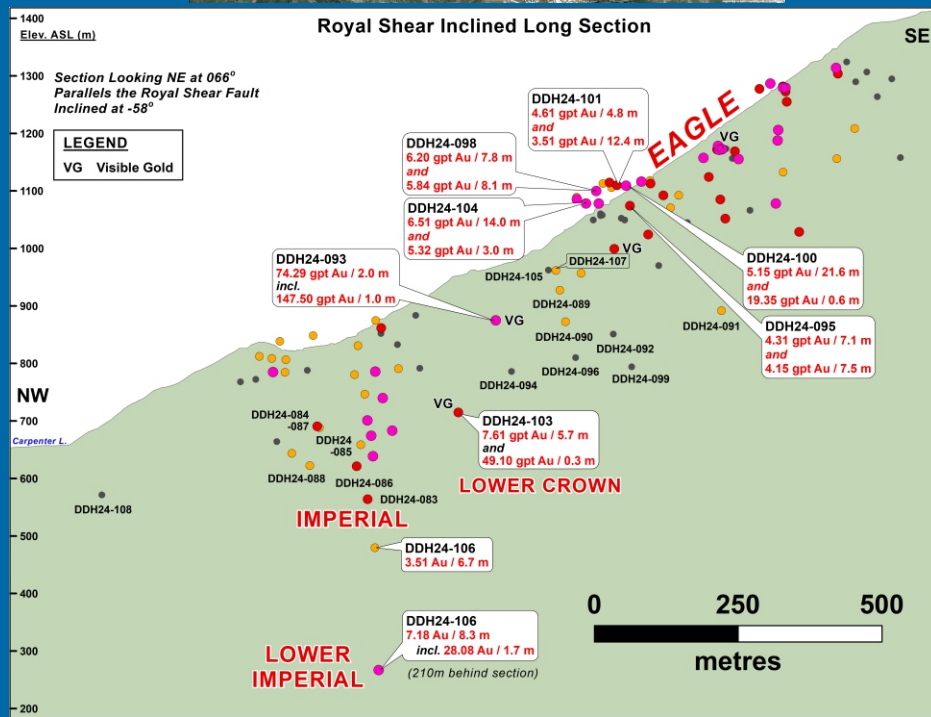
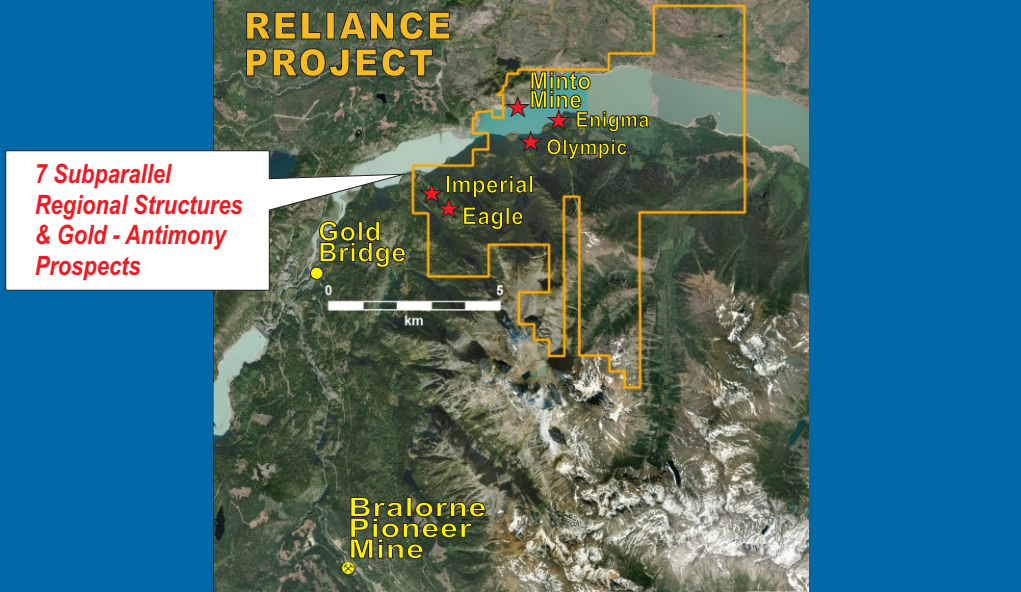

Orogenic Gold

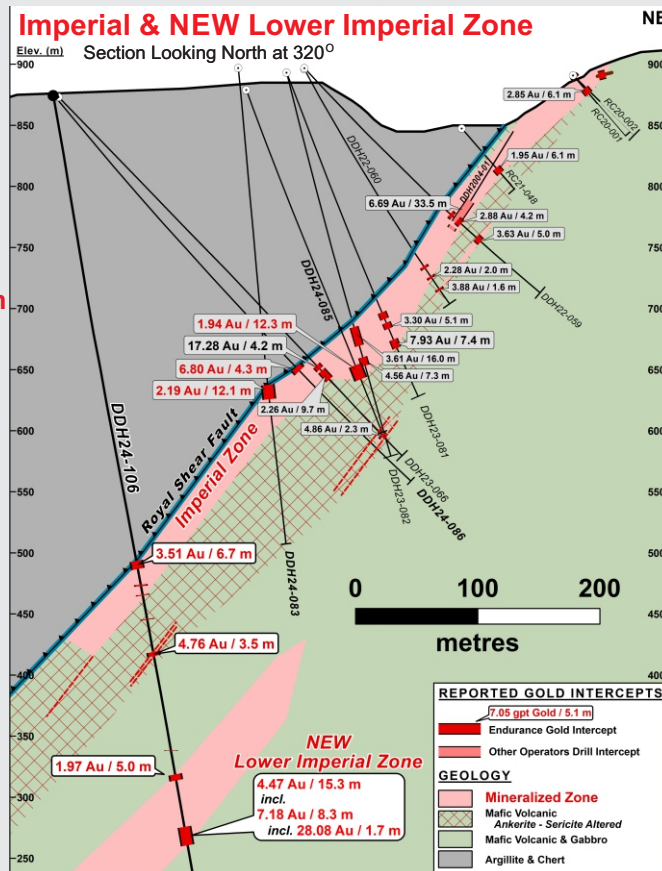
- 10 km NE of Bralorne - Pioneer Mine with +4 million ounces of historic gold production.
- Mineralization is hosted within the 2 km long Royal Shear and defined to 1.1 km vertically.
- Multiple road accessible sub-parallel structural host targets.
- New soil anomalies require drill testing.
- Eagle Zone 550 x 150 m area. Zone averaging 4.70 gpt Gold / 15.7 m in 40 DDH.

Elephant Mtn. Project, Central Alaska (100%) Reduced Intrusive Hosted Gold

- Road accessible in the Tintina Gold Belt, near Manley Hot Springs.
- Reduced Intrusive hosted Stockwork and Shear hosted Gold.
- Seven priority targets over 12 km – 6 targets warrant drilling.
- **South Zone** – gold-in-soil anomaly 1,400 x 250 m - DDH returns **4.0 gpt Gold / 4.6 m**. – untested high priority IP chargeability anomaly.
- **North Zone** – DDH returns **0.4 gpt Gold / 147.1 m**. - Large associated IP chargeability anomaly.
- **Trout Target** – Grab samples up to 23.1 gpt gold. 1,000 x 300 m >100 ppb soil anomaly +25 m wide shear zone – Soil grid includes **high gold-in-soil values up to 2,330 and 2,100 ppb gold**. Trench: 0.510 gpt gold over greater than 12 m.
